


Description:
COMMENCE at the North 1/4 corner of Section 2, Township 22 South, Range 26 East,
Lake County, Florida, thence run S 00°18'50" W along the East line of the Northwest 1/4 of said Section 2 for a distance of 1311.07 feet; thence run N 89°35′54" W along the North line of the Southeast 1/4 of the Northwest 1/4 of said Section 2 for a distance of 659.94 feet to the Northeast corner of the Northwest 1/4 of the Southeast 1/4 of the Northwest 1/4 of said Section 2 and the POINT OF BEGINNING; thence run S 00°18°23" W along the East line of said Northwest 1/4 of the Southeast 1/4 of the Northwest 1/4 and the East line of the Southwest 1/4 of the Southeast 1/4 of the Northwest 1/4 of said Section 2 for a distance of 740.81 feet to the North right of way line of C.R.-455; thence run S 89°45'16" W along said North right of way line for a distance of 72.12 feet; thence run N 85°29'44" W along said North right of way line for a distance of 71.02 feet to the beginning of a non-tangent curve concave to the Northeast, having a radius of 955.74 feet and a chord bearing of N 72°27'38" W; thence run Northwesterly along said North right of way line and the arc of said curve for a distance of 325.53 feet through a central angle of 19'30'56" to the end of said curve; thence run N 62°57'23" W along said North right of way line for a distance of 232.35 feet to the West line of the aforesaid Northwest 1/4 of the Southeast 1/4 of the Northwest 1/4; thence leaving said North right of way line run N 00°17'58" E along said West line for a distance of 536.89 feet to the Northwest corner of said Northwest 1/4 of the Southeast 1/4 of the Northwest 1/4; thence run S 89°35'54" E along the North line of said Northwest 1/4 of the Southeast 1/4 of the Northwest 1/4 for distance of 659.94 feet to the Point of Beginning.
